You are also requested to inform the Officer concerned that, if they have exclusively worked on Civil / Criminal side during the aforesaid period, 2 Judgments in Civil / Criminal matters, as the case may be, of the said period be furnished. In case, if they are on deputation during the above referred period, Judgments of one year prior to the date of their Deputation be furnished. **Judgments written in English language shall be preferred.**
