## Know the Case Status on Mobile Phone (SMS)

(You must have the [case number-year & case type](#))

### Create text message. Steps:

1. <a href="#">ghcs</a> <space>	<i>Gujarat High Court Case Status</i>
2. <Category <a href="#">c/r/o</a> > < space>	(Enter <a href="#">civil</a> or <a href="#">Criminal</a> or <a href="#">oJ</a> )
3. < <a href="#">Case Type</a> >< space>	(Enter the <a href="#">abbreviation of the case type</a> )
4. < <a href="#">Case Number</a> ><space>	(Enter the case number)
5. < <a href="#">Case year</a> >	(Enter the <u>year</u> yyyy of the case number)

### Example: The sample format can be like this:

<b>For Civil:</b>	<a href="#">ghcs</a> <space> <a href="#">c</a> <space> <a href="#">sca</a> <space> <a href="#">150</a> <space> <a href="#">2009</a> (for Gujrat High Court Case Status-Civil-Special Civil Application - 150- of 2009)
<b>For Criminal:</b>	<a href="#">ghcs</a> <space> <a href="#">r</a> <space> <a href="#">cr.ma</a> <space> <a href="#">250</a> <space> <a href="#">2009</a> (for Gujrat High Court Case Status-Criminal-Criminal Misc Application - 250- of 2009)
<b>For Original Jurisdiction:</b>	<a href="#">ghcs</a> <space> <a href="#">o</a> <space> <a href="#">coma</a> <space> <a href="#">350</a> <space> <a href="#">2009</a> (for Gujrat High Court Case Status-OJ-Company Application -350- of 2009)

### The message display will be as shown below:

For *civil*: [ghcs c sca 150 2009](#)  
For *criminal*: [ghcs r cr.ma 250 2009](#)  
For *original Jurisdiction*: [ghcs o ojca 350 2009](#)

Now, **send to phone no.: 56767**, and instantly **get the reply message- the status of the case:**

<**Pending**> or <**Disposed of**> & <**Last or Next Date of Listing**>

If the message is “**Invalid key word**”, recheck the message, particularly Steps 3 & 4, and correct any **error of space-character-number-year**, then send again.
